

NB FOREST TECHNICIANS ASSOCIATION ANNUAL GENERAL MEETING MEETING MINUTES APRIL 3rd, 2014

1) OPEN MEETING

NBFTA President Gareth Davies welcomed members to the 2014 NBFTA AGM held in conjunction with the CWF Spring Meeting at the Delta Beausejour in Moncton, NB.

The meeting was called to order at 1:30 PM with twenty-two NBFTA Members in attendance. Gareth introduced guest speaker Gerry Redmond, Director of the Maritime College of Forest Technology (MCFT).

2) READING & CONFIRMATION OF 2013 AGM MINUTES

First Vice-President Riley Côté-DeMerchant moved approval of the previously distributed minutes of the 2013 NBFTA AGM. The motion was seconded by Allie DeGrace.

3) EXECUTIVE AND COMMITTEE REPORTS:

- PRESIDENT: Motion carried, (moved by Gareth Davies, seconded by Blair DeGrace), to approve the attached report by Gareth Davies.
- 1ST VP & CERTIFICATION COMMITTEE: Motion carried (Moved by Riley Côté-DeMerchant, seconded by Gareth Davies), to approve the attached report by Riley.
- 3 2ND VP & DISCIPLINE COMMITTEE: There was no report available from Second Vice President and Discipline Committee Chair France Roussel who was unable to attend the AGM.
- SECRETARY: Motion carried, (moved by Holly Pees, seconded by Gilles Gallant), to approve the attached report by Holly Pees.
- TREASURER: Gareth distributed an unaudited Treasurers report on behalf of Rebecca Jones who was unable to be in attendance. Motion carried (Moved by Gareth Davies, seconded by Riley Côté-DeMerchant), to approve the attached unaudited report.
- AUDITORS' REPORT: Gareth Davies offered to follow-up with auditor France Roussel, who was not in attendance, to complete a financial audit of the NBFTA finances and to post the results to the NBFTA website.
- PAST PRESIDENT & ADVISORY COMMITTEE: There was no report available from Past President and Advisory Committee Chair Todd MacPherson who was unable to attend the AGM.

- o **Region 1:** Motion carried, (moved by Allie DeGrace, seconded by Blair DeGrace), to approve the attached report presented by Allie on behalf of Jonathan DeGrace who was unable to attend the AGM.
- Region 2: There was no report submitted by Region 2 Representative Lance Crain who was unable to attend the AGM.
- Region 3: There was no report submitted by Region 3 Representative Paul Gilmore who was unable to attend the AGM because of an injury.
- o Region 4: Motion carried, (moved by Blair DeGrace, seconded by Allie DeGrace), to approve the attached report presented by Blair.
- PUBLIC RELATIONS: There was no Public Relations Committee report presented.

- CONTINUING FOREST EDUCATION: Riley Côté-DeMerchant advised that CFE issues were addressed in the Certification Committee report.
- MAZIMUTH: Azimuth newsletter editor Riley Côté-DeMerchant advised that there was no activity to report.
- MEMBERSHIP: There was no Membership Committee report presented.
- MCFT DIRECTOR'S REPORT: MCFT Director Gerry Redmond updated attendees on the following issues relating to the operation and administration of the College:
 - Current Director Redmond assumed accountability after retirement of Robert Whitney at the end of February, 2014. Several staffing and succession issues were addressed in the past year.
 - College accredited by the North American Wildlife Technology Association, the Society of American Foresters, and the College of Eastern Forest Technology Schools.
 - o Potential additional future advanced diplomas include Wildfire Management and Geomatics.
 - The Fish and Wildlife Certificate complements and does not take away from or diminish the Forestry Program. A wet lab was constructed for the F & W Program.
 - o Successful student recruitment with 100 applicants for an annual intake of 60.
 - o Potential to collaborate with NBFTA in forming an alumni MCFT association.
 - Welcome recommendations for potential MCFT Continuing Education offerings.
 - MCFT Lease finalized for a 400 ha research forest at Kingsclear 12 minutes from MCFT.
- MFRS BOARD OF GOVERNORS: Motion carried, (moved by Blair DeGrace, seconded by Allie DeGrace), to approve the attached report presented by Blair DeGrace.
- **SOLUTION COMMITTE:** There was no Constitution Committee report presented.
- TREE HOUSE: There was no Tree House Committee report presented.

4) READING OF CORRESPONDENCE

- Allie reported that he had followed up with the treasurer after receiving emails from three members concerned that they had not received response to membership applications and cheques had not been cashed.
- Gareth advised that he had communicated with the newly elected Association of Registered Professional Foresters of NB (ARPFNB) President Don Floyd. President Floyd advised that the "Right to Practice" initiative had been shelved and that ARPFNB was open to closer collaboration with the NBFTA. The high cost of the failed right to practice project had strained ARPFNB resources and he would be open to the possibility of both Associations sharing administrative resources. Gareth responded to a question by Chris Spencer that ARPFNB interest in the NBFTA may possibly be financially motivated.

5) UNFINISHED BUSINESS

- The Certification Committee, Chaired by Riley Côté-DeMerchant, is to follow-up on a motion from the 2013 NBFTA AGM concerning an arrangement with the Canadian Institute of Forestry (CIF) where NBFTA members would receive annual CIF membership for an annual fee of \$3,000.
- Allie commented that CFT status remains valid until an NBFTA Member receives notification stating otherwise. Riley stated that he plans to explore CFE opportunities such as partnering with Fundy Model Forest offerings where NBFTA may consider sharing costs.
- Dusty commented that declining membership and inactivity stems from a lack of communication. He proposed enhanced contact through email and renewed distribution of the Azimuth Newsletter. Dusty offered to assist Riley Côté-DeMerchant with publication of the Azimuth.

6) ELECTION & INSTALLATION OF OFFICERS

- Region 4: Blair DeGrace reported that Pamela Poitras Hurley of Edmundston accepted accountability for Region 4 (see attached email from Pamela).
- Section Committee: Riley Côté-DeMerchant accepted continued accountability for this role.
- TREASURER: Chris Finnamore was nominated by Allie DeGrace and seconded by Chris Spencer. An acceptance letter is attached from Chris.
- SECRETARY: Blair DeGrace accepted Allie DeGrace's nomination that was seconded by Gilles Gallant.
- 2nd VICE-PRESIDENT: Allie DeGrace accepted Blair DeGrace's nomination, was seconded by Dusty Corey.
- 1st VICE-PRESIDENT: Riley Côté-DeMerchant advised that he planned to continue in his role as First VP.
- PRESIDENT: Gareth Davies advised he made the decision to step down as president. France Roussel was nominated by Fred Harris and seconded by Allie DeGrace. An acceptance letter is attached form France.

7) NEW BUSINESS

Chris Spencer questioned if the NBFTA should create and communicate a position statement concerning the newly announced NB Crown Lands Forest Strategy. There was a lengthy discussion where members expressed diverse views on the subject.

Riley Côté-DeMerchant advised that he would post a link on the NBFTA website to the strategy document released by the province.

There was discussion, but no consensus, on forming a NBFTA committee representing all interests (DNR, Private Woodlot, Industry, and Environmental) to develop a written position paper for consideration by the Executive Committee. Chris expressed that he felt that it may not be possible to reach consensus. Riley offered to make a posting on the NBFTA Website notifying members to contact the executive if they were interested in forming such a committee.

There were no motions on this issue.

Matthew Tucker invited NBFTA Members to the Atlantic Vegetation Management Association's Annual General Meeting on August 16 – 18, 2014. Additional information can be found at the AVMA website.

8) NOMINATE AUDITORS FOR 2015 AGM

A motion was carried (Allie DeGrace/Marcel Maillet) appointing Rebecca Jones as auditor for 2015.

9) SELECT DATE & LOCATION OF 2015 AGM

A motion was carried (Blair DeGrace/Allie DeGrace) setting the date of the 2015 NBFTA Annual General Meeting in conjunction with the Canadian Woodlands Forum Spring Meeting.

Allie DeGrace moved conclusion of the 2014 NBFTA AGM at 3:35 PM.

This report summarizes the Maritime College of Forest Technology (MCFT) Board of Governors activities spanning the period from May 2013 to April 2014.

BACKGROUND

The NBFTA'S initial involvement in the MCFT Board of Governors was by invitation to its Annual Meeting on April 23, 1999. A vacancy had been created by the departure of representation from Newfoundland due to a forestry technical program being developed at the College of the North Atlantic. Andrew Clarke represented the NBFTA for the period of 1999 - 2000. The writer has represented the NBFTA from April 2001 to present.

MCFT BOARD OF GOVERNORS AND EXECUTIVE COMMITTEE MEETINGS

The MCFT Board of Governors Executive Committee met on September 14, 2013 principally to review financial aspects of the operation:

- Review of accounting, financial and auditing issues.
- Detailed review of financial statements.

The MCFT Board of Governors met on September 19, 2013. Issues arising include the following:

- W UNB developing a Major in Urban Forestry. MCFT may consider modifying its Urban Forestry program to align with what UNB will be offering.
- School Administration to contact DNR Departments of the Maritime Provinces to encourage stronger participation in the MCFT Board activities.
- Discussion on core forestry mission of MCFT. Fish & Wildlife, Urban Forestry, and other disciplines augment the value of the program, but do not take away from the forestry competency of the graduate.

^{*} Executive Committee Members

- Organizational changes: Of 41 courses delivered over a 2 year curriculum, 21 courses have changes in instructional staff.
 - o Robert Whitney retired at the end of February of 2014.
 - o Gerry Redmond replaces Robert as MCFT Director.
 - o Rod Cumberland moved into the fish and wildlife program replacing Gerry Redmond.
 - o David McDonald and Kenny McGinn retired in June 2013.
 - Gareth Davies was tasked with additional courses of Silviculture II and Forest Business in addition to Silviculture I, and Forest Entomology.
 - Sarah Weatherby, previously a contract instructor, was hired full time to teach Botany, Public Speaking, and Urban Forestry.
 - o A new Operations Supervisor, Jeff Szo was hired in July 2013.
 - o Unreliable financial reporting led to the dismissal of the MCFT bookkeeper. Financial administrative staff currently includes Financial Officer Stacey Estey supported by Clerk Jackie Taker.
 - o 2011 graduate Natasha Ouellette was hired to assist with recruitment on a seasonal basis.
- MCFT is in a stable financial standing. The Auditor provided a clean audit report up to April 30, 2013.
- The Board voted to permanently suspend, effective April 30, 2014, the retirement allowance for MCFT employees which provided for a payment at retirement of one week of pay for each year worked up to a maximum of 25 years.
- Maritime Provinces Higher Education Commission (MPHEC) operating grant amount to MCFT remains unchanged from the previous year.
- Tredericton Campus:
 - o Twice as many applicants as the 60 first year openings, thanks largely to effective recruitment efforts.
 - o Of 47 second year students returning in September 2012, 45 graduated on April 19, 2013.
 - o 20% female enrolment
 - o Average age of first year students is 19, with average academic standing of 80% at high school graduation.
 - o First time fall camp planned for Fundy Park. Activities to include salmon and bark beetle surveys, and wetlands rehabilitation.
 - o A high number of MCFT grads continue to take advantage of the articulation agreement with UNB.

Bathurst Campus:

- o 11 graduates on April 19, 2013.
- o Of 16 students registered for the September 2013 intake, only 13 showed up for enrolment.
- A new instructor Ken Bouchard was hired.
- o Retired Associate Director Claude Chiasson returned on a contract basis to teach urban forestry.
- o An Articulation Agreement was signed between MCFT Bathurst Campus and University de Moncton. 47 credit hours and a \$2,000 bursary will be awarded to a MCFT student wanting to further their education through a U de M bachelor degree.
- MCFT maintains accreditations with the Society of American Foresters, The College of Eastern Forest Technology Schools, and the North American Wildlife Technology Association.
- A strong job market exists for graduates and students. Employment opportunities outnumbered graduates and returning students.
- The Continuing Education Department continues to contribute to the financial standing of the College from another year of net profit. CE Director Tim Cameron presented a CE Business Plan to map out the long term delivery of the program.
- There was communication between NB Forest Products Association representatives and MCFT administration concerning the use of MCFT resources by instructor Rod Cumberland to communicate his views on forest management to the NB Forest Network and the media.

Closing

College Administration and Board members continually strive to improve academic quality, facility operations, and to sustain the core values the College is noted for.

In his final report to the Board, Director Whitney wrote: "By any standard, 2013 has been a successful year for MCFT. Application numbers are high; enrolment is at its maximum level at both campuses; attrition is low; jobs for students are plentiful; the College is financially stable; faculty and staff are happy and motivated; facilities are in excellent condition; the future is stable and promising".
