YSC is looking for an individual who enjoys interacting with woodlot owners and contractors and who would like to experience the multi-aspects of private land management and implementing the many objectives (climate change, wildlife, recreation, fibre production, biodiversity, carbon, succession planning etc ) that come with it.

You would be joining our experienced Private Land Forest Management team in a **wide variety of duties** including:

- Traveling throughout the 3 counties to oversee silviculture treatments and ensure these treatments follow the proper guidelines and pre-determined criteria.
- Measuring these sites using GPS and collecting pre and post treatment data and organizing it accordingly.
- Communicating clearly with landowners and contractors to ensure the owners' questions and concerns are answered and qualified sites are scheduled for treatment in an organized timely manner.
- Data collection and compilation for woodlot owner management plans.
- Walking woodlots with owners providing advice and guidance on various aspects of forestry
- Woodlot owner outreach and education.
- Answering day to day calls/email requests and assisting senior staff with special projects as needed.

We are looking for someone who:

- has good communication and people skills.
- is organized, conscientious with good work ethics and willing to learn.
- has knowledge of GPS and GIS systems.
- is comfortable working alone for periods of time in the woods.
- is physically able to endure extended periods of walking through various types of forest terrain and adverse weather conditions (within reason).
- is innovative and able to envision new ways of achieving goals.
- has their own or access to a vehicle for field work - mileage will be compensated.

**Education** – Post-Secondary Forestry Education - Forest Technician or Forester.

**Duration** - Seasonal (possibility of extension) – May 6 to December 31, 2024
